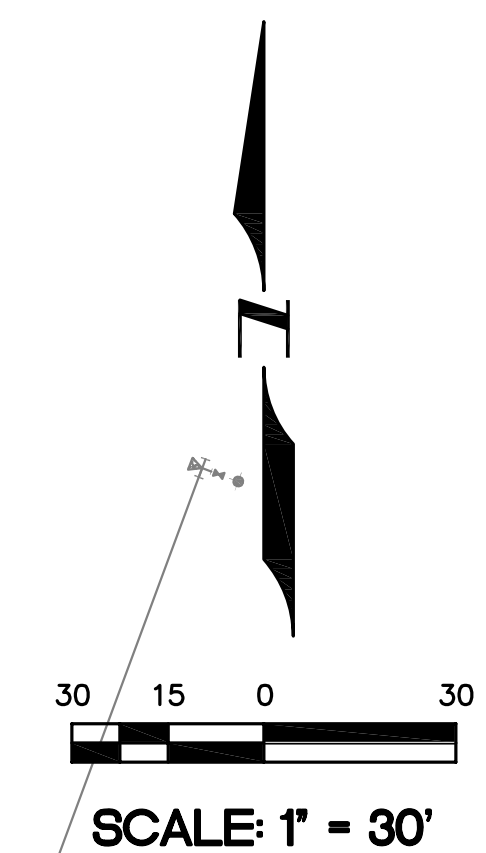
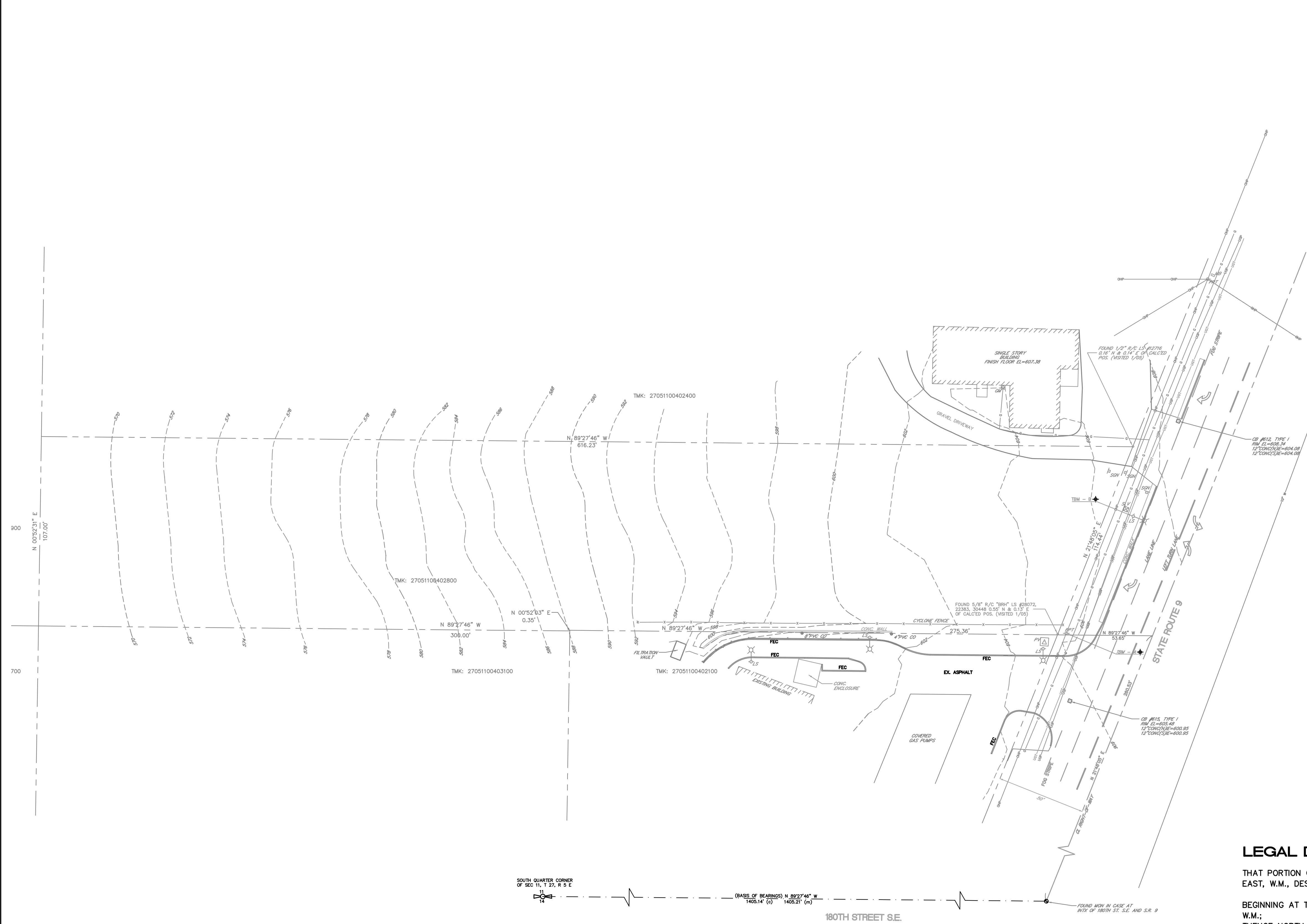

 THENCE NORTH 89°29'09" WEST 1275.90 FEET ALONG THE SOUTH LINE OF SAID SECTION TO A POINT ON THE CENTERLINE OF THE STATE HIGHWAY AS NOW LOCATED;
 THENCE NORTH 21°41'28" EAST 260.53 FEET ALONG THE CENTERLINE OF SAID STATE HIGHWAY;
 THENCE NORTH 89°29'09" WEST 32.17 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION;
 THENCE NORTH 89°29'09" WEST 296.82 FEET;
 THENCE SOUTH 0°51'08" WEST 0.35 FEET;
 THENCE NORTH 89°29'09" WEST 300.00 FEET;
 THENCE NORTH 0°51'08" WEST 107.00 FEET;
 THENCE SOUTH 89°29'09" EAST 637.45 FEET TO A POINT ON THE WEST MARGIN OF THE STATE HIGHWAY;
